DESCRIPTION:

QUIKRETE® Oil Stain Remover

COVERAGE:

Treats 24 sq. ft. per gallon when spread using a 1/4" V-notched spreader.

DIRECTIONS:

SHAKE WELL BEFORE USE. Always test a small area before use. Do not use on wet surfaces. For best performance, use when temperature is above 60°F (16°C).

1. Scrape off buildup and sweep area.
2. Apply to stain, starting one inch beyond perimeter and working toward the center.
3. Allow 5–8 hours to dry.
4. Sweep up powder.
5. Immediately rinse the area with a strong stream of water.
6. Provide adequate ventilation and allow moisture to evaporate.

If stain remains, reapply, scrub with stiff-bristled brush and repeat steps 3 thru 6.

PACKAGING:

1/2 Gallons–6 Pack

CAUTION:
